<p style="text-align: center;"><b>CHIEF JUDGE ORDER REGARDING COURT OPERATIONS BEGINNING JULY 6, 2021</b></p>	

**I. BACKGROUND**

On May 17, 2021 Chief Justice Brian Boatright issued his Order Regarding Safety in Colorado Courthouses, which continued the requirement that all people in the public areas of Colorado Courthouses wear masks until June 18, 2021. This order left it to each Chief Judge to consult with local health authorities to decide what social-distancing requirements should be continued.

The Chief Justice’s May 17, 2021 order expired June 18, 2021. On June 18, 2021, the Chief Justice issued his Updated Order Regarding Safety in Colorado Courthouses. Beginning June 19, 2021, the chief judge of each judicial district is authorized to determine mask and social-distancing requirements for courthouses and probation offices in their judicial district. Chief judges must make these decisions in consultation with local public health officials after consideration of local circumstances, including vaccination rates, COVID positivity rates and other COVID metrics, courthouse layout, and staffing needs.

In entering this Chief Judge Order, I have consulted with the health departments for both El Paso County and Teller County.

Since Fourth Judicial District CJO 21-07 issued on May 18, 2021, the Covid-19 incidence numbers have been steadily declining in both El Paso and Teller Counties, as shown in the graphs on the following page:

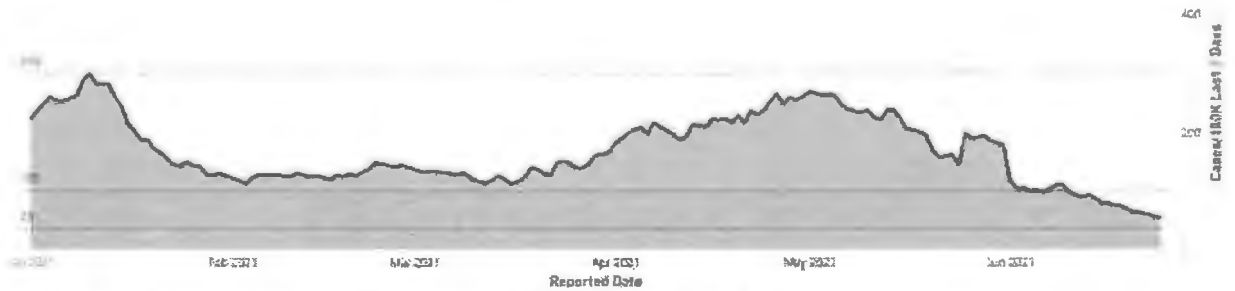

7-Day Incidence per 100,000



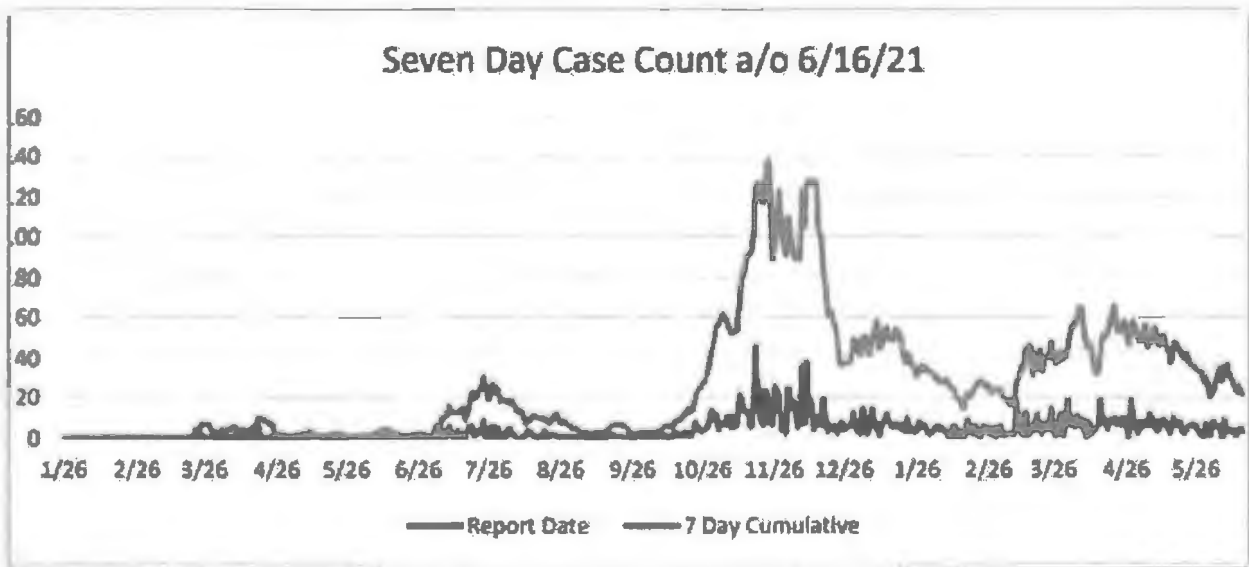

Since April 2, 2021, all adult citizens in Colorado have been eligible to obtain a Covid-19 vaccination. I find that those citizens who want to be fully vaccinated have had ample opportunity to be fully vaccinated.

## II. MASK AND SOCIAL DISTANCING ORDERS ARE RESCINDED

In light of the above information, I hereby substitute this order for all of my previous Covid-19 Chief Judge Orders.

**Starting July 6, 2021, masks will no longer be required in the courthouse, with the exception that all jail inmates shall be masked when they are in any courthouse.**

Anyone in the courthouse who has not been fully vaccinated is encouraged to wear a mask in the courthouse.

**Social distancing is no longer required, although distancing is encouraged for those who are not fully vaccinated.**

### **III. JURY TRIALS**

**Jury trials will no longer be limited in number, as they have been since July 2020.** Beginning July 6, 2021, 300 Jurors will be summoned for 8:00 a.m., with more jurors available later in the day, as needed.

### **IV. WEBEX**

The courts have relied on Webex to conduct most of their business for more than a year. Webex has proven to offer an efficient method of communication for some court appearances, especially those lasting only a few minutes.

**The judicial officers and staff for the Fourth Judicial District are encouraged to preserve the use of Webex where there are significant efficiencies to be gained for stakeholders, especially for court business not lasting more than several minutes.**

### **V. SELF-HELP CENTER**

The self-help center at the El Paso County Courthouse will be open 7:30 a.m. to 4:30 p.m. Parties without attorneys are encouraged to e-file through the Colorado Courts E-filing (CCE) system or by mail. There will no longer be a drop box at the front entrance to the El Paso County courthouse, nor will parties be permitted to email documents to the Clerk of Court (COC) email address. **VI. DIVISION CVL**


This order does not affect **Division CVL's Operating Order**.

**VII. PROBATION**

The Probation Department is returning to conducting most business in person at its courthouse offices. All defendants sentenced to probation or ordered to complete any kind of evaluation or a Pre-Sentence Investigation on or after July 6, 2021 must report in person immediately to the probation office. Video conferencing appointments will be scheduled on a case-by-case basis by the assigned probation officer. The probation lobby hours are Monday-Friday from 8:00am-5:00pm.
